

## LETTER OF ACKNOWLEDGEMENT – TEMPORARY ISOLATION/REINSTATEMENT

Dear Customer,

Thank you for choosing Safe Power Services to perform the isolation of your property from the Orion Network. In order for us to carry out this work on your behalf we need you to fulfil a number of requirements as listed below along with completing the following questionnaire.

- A close approach consent is required to work within 4m of overhead power lines or to excavate within 5m of a power pole.

- If any electrical work is performed on-site during the period of isolation from the network, we
  require an electrical certificate of compliance (COC) and electrical safety certificate (ESC) from
  your electrician. This must be provided via email to <a href="mailto:office@safepowerservices.co.nz">office@safepowerservices.co.nz</a>, 24-hours
  prior to the time of livening the property. We will NOT attend site without receipt of this
  certificate.
- Please be aware that if no electrical work is scheduled, we recommend that you have an
  electrician complete a certificate of verification (COV) as this will ensure the job can proceed on
  the date and time requested. Not having a COV means that if our worker finds that the
  installation is electrically unsafe for continued use on visual inspection, we will not be able to
  reinstate the power until the unsafe component has been remedied, or if that isn't possible, the
  job will be turned down and a site visit will be charged.
- When we are attending a site that has not had a COV completed, we will require access for our worker to complete his visual inspection. This includes earthing, MEN compatible installation and no access to live parts. Thus, someone must be on property at the time of isolation and/or livening to allow entry or, alternative means need to be arranged with Safe Power Services, prior to attending, to ensure access. Note: if the site is unattended at the time of livening, the mains switch will be turned to the off position leaving the rest of the installation isolated.
- If we attend the site and an electrical installation is non-compliant, or we are unable to conduct the temporary isolation /disconnection you will be charged the full rate for the isolation of \$250.00 + GST.
- Safe Power Services can only verify the electrical workmanship of work completed by Safe Power Services contractors/employees from the Orion network to the installation.
- Isolations are conducted between 7:30am 10:00am, Monday Thursday. Friday bookings are only available by prior arrangement/agreement.
- Reinstatements are conducted between 3:30pm 4:30pm, Monday Thursday.
